

## **Lockington Parish Council**

### **Biodiversity Policy**

**Adopted on:** July 2024

#### **Introduction**

This policy responds to the strengthened biodiversity duty introduced by the Environment Act 2021. Lockington Parish Council is committed to conserving and enhancing biodiversity within its jurisdiction. Biodiversity—the variety and abundance of life—supports ecosystems critical to human and environmental well-being.

#### **Policy Objectives**

[Council Name] will:

1. Conserve and enhance biodiversity in all council decisions, operations, and activities.
2. Embed biodiversity considerations into planning processes, supporting developments that protect and improve habitats.
3. Raise awareness of biodiversity issues within the community, encouraging residents to take part in biodiversity initiatives.
4. Manage council-owned land to protect and enhance biodiversity.
5. Collaborate with local organisations, businesses, and residents to promote biodiversity.
6. Monitor and review biodiversity efforts to ensure progress and identify new opportunities for enhancement.

#### **Commitments**

The council will:

- **Decision-Making and Planning:**
  - Consider biodiversity impacts in council meetings and decisions, aiming to minimise adverse effects while identifying opportunities for biodiversity gains.
  - Support planning applications that integrate habitat conservation or creation and oppose developments harmful to sensitive ecosystems.
  - [Include biodiversity-specific clauses in the council's neighbourhood plan.]
- **Community Engagement and Education:**
  - Communicate biodiversity-related information via the council's website, newsletters, and public events.
  - Encourage and support local biodiversity projects, such as wildlife corridors, tree planting, and wildflower meadows.
  - Partner with schools to educate young people on the importance of biodiversity.

- Organise public events such as [BioBlitzes](#) and workshops on biodiversity friendly practices.
- **Council Land Management:**
  - Conduct biodiversity audits of council-managed land to identify opportunities for improvement.
  - Implement biodiversity-friendly maintenance practices, such as:
    - Reducing or eliminating pesticide and herbicide use.
    - Leaving areas of grass unmown to encourage pollinators and wildlife.
    - Planting native trees and shrubs.
  - Create dedicated spaces for wildlife, such as installing bird boxes, bat roosts, and log piles.
  - Remove invasive species in compliance with appropriate legislation.
- **Partnerships and Collaboration:**
  - Work with conservation organisations, businesses, and residents to implement biodiversity strategies.
  - Engage with local businesses to encourage biodiversity-positive practices.
  - Collaborate with Principal Authorities on verge management to support biodiversity while ensuring safety.

## Monitoring and Review

- **Implementation Monitoring:**
  - Biodiversity efforts will be monitored annually, with progress evaluated against biodiversity audit results.
- **Policy Review:**
  - The policy will be reviewed every two years or earlier if legislation requires.
