Feedback from the Ward Councillor, Jeremy Wilcock.

ERYC Highways budget for 2025 – 2026 has been increased from £15 M up to £ 22 M.

The Ward Councillor sits on the Environment and Regeneration Committee, and in the last meeting, this committee stated that they would act proactively, not reactively.

No update on the Kingfisher Solar Farm.

Dogger Bank D Statutory consultation opened 10<sup>th</sup> June 2025. Parish Councillor Ian Jowett will attend two of these meetings and will provide feedback at the next meeting.

The Chairman, Parish Councillor John Rowson, had been contacted by a resident concerning the Dogger Bank D cable route. The resident was concerned that the planned route would cross Bealeys Lane at Bealeys Beck, a local beauty spot. The Ward Councillor was asked to investigate this concern with urgency.

24-25/15 Parish Council ongoing Business Matters:

15.1 Expression of Interest Form – Replacement Bus Shelters – No update.

15.2 Village Green – Bench Positioning

This was discussed at length. It was agreed for the VG ST to consider Parish Councillor Jeremy Mason's view regarding grouping benches on the VG.

Clerk to ensure this item is on the agenda for the July meeting.

15.3 Millennium Copse – Land registration

The Clerk explained that he had received some unofficial advice from ERNLLCA stating that if we own land, we should ensure it is registered with the Land Registry. The pros and cons of this were discussed.

Parish Councillor Jamie Wheldon volunteered to take this away and discuss with our Solicitor.

15.4 Aike Notice Board (NB) update.

The Chairman, Parish Councillor John Rowson, had received a quote for a new NB. The quote was for £1500 + VAT, which included new legs as well as NB. The PC felt that this quote was too expensive.

Parish Councillor Ian Jowett volunteered to take this away and discuss with Parish Councillor Amanda Jordan.

15.5 Website – Gov.UK Domain

The Clerk give feedback on this topic, explaining that the initial build cost would be £500 + VAT. Additionally, there is an ongoing annual cost of £350 plus VAT.

This additional cost is currently unacceptable, as we currently receive this service free from ERYC.

15.6 Memorial Bench Kevin Marshall

Linda Marshall has very kindly donated a memorial bench to be placed on the village green. A brass plaque will be fitted to this bench in memory of Kevin Marshall.

When the benches are in place, it is planned to hold a Village Green opening day (we should receive the benches by the end of June). The proposal is to hold this on Saturday, August 23, 2025, in conjunction with the village pub night.

Clerk to circulate the draft wording of the memorial plaque for comment.

15.7 Road Markings at village entrance.

The road markings at the entrances to the Village require repainting.

Clerk to request this from ERYC Highways.
