5.3 'Book Stop' for Lockington.

This was debated, and it was decided that more information was needed before a final decision could be made. In principle, the PC agreed this could be of interest.

5.4 Dog Fouling in the Village

Dog fouling is on the increase in the village, particularly in Dead Lane, Front Street, Church Lane and Aike. It was agreed to erect signs in the relevant places to remind people of the Countryside Code.

Action: Parish Councillor Andrew How had volunteered to draft a notice.

5.5 Aike Notice Board replacement – design and budget.

It was agreed that the Aike notice board required replacement. The PC set aside a budget of up to £500 to replace the notice board.

Action: Parish Councillor John Rowson volunteered to get some quotes for the replacement board.

5.6 Village Green – Planting of Wildflower Grass seed.

It was agreed to plant the Wildflower seed on the RHS of the entrance to the green, where the new soil has been laid. The plan is to sow the seed in mid-May.
