Crown reduce 1 no. Corsican Pine (Tree 1) by 1.5 metres to the lowest branches tapering to 0.5 metres at the uppermost branches as illustrated to maintain its current shape and height, whilst reducing the spread, and remove 1 limb protruding over the shared driveway; Crown reduce one no.
